## **SOUTHERN SELECT SOUTH POLL CATTLE SALE**

### **Sale Consignment Rules**

1. Annual membership to the SPGCA must be current and paid.
2. SSC reserves the right to refuse consignment or sale of any animal.
3. All animals, including calves at the side of their dams (with the exception of a steer calf), must be registered with the SPGCA by 10/6/25.
4. The deadline for consignment entries to be submitted is 10/6/25.
5. A quality picture of each consignment must be provided by the consignor. Videos are encouraged and may be used for promotional purposes.
6. Only select Fullblood and Purebred animals are allowed in the sale. No percentages.
7. All animals must have a permanent ID (ie. Tattoo, Brucellosis Tag, Brand, or EID)
8. Consignments must arrive at the sale facility with a health certificate issued by a licensed veterinarian within 30 days of the sale.
9. Consignments must arrive at the sale facility on Thursday 12/4/25.
10. SSC will issue each producer tags with appropriate lot numbers for each consignment to be tagged, 2 weeks prior to arrival for the sale.
11. Bulls over 12 months of age at the time of the sale, must pass a Breeding Soundness Examination (BSE) and be Trichomoniasis tested negative by a licensed veterinarian.
12. For every bull consigned, you must consign 2 females.
13. All weaning aged animals being sold without their dam, must be weaned a minimum of 30 days prior to the sale.
14. All females being sold as bred, must be pregnancy checked and verified by 10/6/25.
15. Consignor agrees to guarantee the pregnancy of their females being sold as bred.
16. Consignor agrees to provide sire DNA information to the buyer of a bred animal.
17. The opening bid price will be \$3,000 on open heifers; \$3,500 on bred heifers; \$3,000 on bulls; \$4,500 on pairs. If animals do not meet minimum prices, they will be considered "No Sale."
18. All transfers will be handled and paid for by SSC.
19. The consignment fee is 10% of the sale price.
20. In the event of a "No Sale," there will be a consignment fee of \$250.00.
21. All transactions are between the seller/buyer.
